

ORDINANCE NO. TR-3264

AN ORDINANCE RELATING TO TRUCK ROUTES IN THE CITY OF OVERLAND PARK, KANSAS; AMENDING AND REPEALING EXISTING OVERLAND PARK MUNICIPAL CODE SECTION 12.12.040 AND PROVIDING A SUBSTITUTE PROVISION THEREFOR.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OVERLAND PARK, KANSAS, AS FOLLOWS:

Section 1. Overland Park Municipal Code Section 12.12.040 is hereby amended to read as follows:

12.12.040 Truck Routes Designated.

The following streets are hereby designated as truck routes within the limits and jurisdiction of the City:

- A. Merriam Drive - east-west through City
- B. Johnson Drive - east-west through City
- C. Shawnee Mission Parkway - east-west through City
- D. 75th Street - east-west through City
- E. 80th Street - from Santa Fe Drive to Metcalf Avenue
- F. Santa Fe Drive - from 80th Street to 87th Street
- G. 87th Street - from the west City limit to Santa Fe Drive
- H. 95th Street - east-west through City
- I. 103rd Street - from the east City limit to Quivira Road
- J. College Boulevard - east-west through City
- K. 119th Street - east-west through City
- L. 127th Street - from Pflumm Road to Antioch Road and from Metcalf Avenue to Nall Avenue
- M. 135th Street - east-west through City
- N. 143rd Street - from Pflumm Road to Nall Avenue
- O. 151st Street - from the west City limit to Nall Avenue
- P. 159th Street - from Quivira Road to Mission Road
- Q. 175th Street - from Lackman Road to 179th Street
- R. 179th Street - east-west through City
- S. Pflumm Road - from College Boulevard to 143rd Street
- T. Quivira Road - from the north City limit to 143rd Street and from 151st Street to 159th Street
- U. Switzer Road - from 119th Street to 159th Street

- V. Antioch Road - from the north City limit to 167th Street
- W. Blue Valley Parkway - from 119th Street to U.S. 69 Highway
- X. Metcalf Avenue - north-south through City
- Y. Nall Avenue - from the north City limit to 159th Street
- Z. Roe Avenue - from 103rd Street to Tomahawk Creek Bridge

Section 2. Existing Overland Park Municipal Code Section 12.12.040 is hereby repealed.

Section 3. This Ordinance shall take effect and be in force as of the date of its passage, approval and publication as provided by law.
